For over 100 years, the New York Building Congress has advocated for investment in infrastructure, pursued job creation, and promoted building preservation and growth in the New York City region, but the work of our members and the critical issues facing the building industry extend far beyond state lines. With the successful passage of the Infrastructure Investment and Jobs Act, our members will be hard at work building roads, bridges, and public works across the nation.

The Building Congress represents over 550 organizations comprised of more than 250,000 skilled tradespeople and professionals, including architects, engineers, contractors, labor, owners, and all who play a role in building America's renowned structures. From family-owned contracting companies to public authorities, from small businesses to multi-national design and construction firms, the Building Congress' diverse members work on important projects in all 50 states.

Building Congress members design and build homes for our families, offices for our workforce, and schools for our children. When we look up at the iconic structures that make up what we see every day as Americans, and in the pictures we share with our friends and family, Building Congress members are there, hard at work. We build cultural institutions, healthcare facilities, communication networks, parks, and so much more.

In terms of transportation infrastructure, our members design, construct, and maintain subways, streetcars, bus and bike ways, roads, bridges, tunnels, ports, and airports. Building Congress members create what our communities need. With passing of the Infrastructure Investment and Jobs Act we can continue to positively impact the lives of all Americans.




To quantify this impact, New York Building Congress Across America takes a representative sample of the membership and examines the range of member projects in all 50 states.

METHODOLOGY

The Building Congress surveyed 75 organizations represented on its Board of Directors and the New York Building Foundation's Board of Governors. Projects from across the U.S. over the past three years were examined using a member questionnaire and information from Dodge Data and Analytics.


Members represented in this report may not have been represented in prior reports, and therefore identifying trends from prior years is not possible. This report is intended to be a snapshot of current projects being designed, under construction or were recently completed.





Of the Building Congress members surveyed, 36 organizations are performing work outside of New York State and 30 outside of the Northeast. Based on the U.S. Census Bureau-designated regions, 56 percent of total projects are located in the Northeast, valued at \$372 billion. The South follows with 22 percent of projects, valued \$106 billion; the West has 12 percent, valued at \$118 billion; and the Midwest has 9 percent, valued at \$38 billion.





PROJECTS BY TYPE

The Building Congress takes a wholistic approach to the built environment, and as such, members are contributing to a wide array of projects. Leading in total count and value, the top five types of projects are offices, educational facilities, multifamily housing, retail, and streets.

Just over three-quarters of the total value of projects is owned by the private sector, and of public sector projects, the majority are owned by state governments and authorities.

In terms of construction type, over half of the total value of projects are major alterations; over a third are new construction; just under a tenth are additions, and approximately two percent are interior work.
