In accordance with New York State law, Schneiderman 2018 will accept no more than \$60,800 per election cycle (\$19,700 for the primary/\$41,100 for the general) from individuals, unions, political action committees (PACs), trade associations, and limited liability companies (LLCs). Partnerships (including LLPs) that make contributions in excess of \$2,500 will be required to specifically identify the partners responsible for the contribution. Total contributions from a corporation may not exceed \$5,000 per calendar year. It is strictly prohibited to reimburse another individual's or entity's contribution. All contributors must be either US citizens, US entities, or permanent resident aliens (green card holders). Contributions are not deductible for income tax purposes.
